# Medidata Solutions Set to Join S&P MidCap 400; McDermott International to Join S&P SmallCap 600

NEW YORK, June 20, 2017 /<u>PRNewswire</u>/ -- S&P SmallCap 600 constituent Medidata Solutions Inc. (NASD: MDSO) will replace PrivateBancorp Inc. (NASD: PVTB) in the S&P MidCap 400, and McDermott International Inc. (NYSE: MDR) will replace Medidata Solutions in the S&P SmallCap 600 effective prior to the open on Monday, June 26.
