

# S&P Global Declares Quarterly Dividend

NEW YORK, Oct. 29, 2018 /PRNewswire/ -- The Board of Directors of S&P Global (NYSE: SPGI) has approved a regular quarterly cash dividend on the Corporation's common stock. The dividend of \$0.50 is payable on December 12, 2018, to shareholders of record on November 28, 2018. The annualized dividend rate is \$2.00 per share.

The Company has paid a dividend each year since 1937 and is one of fewer than 25 companies in the S&P 500® that has increased its dividend annually for at least the last 45 years.
