

# S&P Global's Annual Shareholders Meeting Accessible by Internet and Telephone - 11 a.m. EDT, Wednesday, April 26, 2017

NEW YORK, March 22, 2017 [/PRNewswire/](#) -- S&P Global's (NYSE: SPGI) 2017 Annual Shareholders Meeting is scheduled for Wednesday, April 26, 2017, at 11 a.m. Eastern Daylight Time.

Charles "Ed" Haldeman, Jr., Chairman of the Board, will preside over the meeting and Douglas L. Peterson, President and Chief Executive Officer, will offer remarks immediately following the business portion of the meeting. The discussion may include forward-looking information.
