

Cara Therapeutics Set to Join S&P SmallCap 600

NEW YORK, April 5, 2021 /PRNewswire/ -- Cara Therapeutics Inc. (NASDAQ:CARA) will replace MTS Systems Corp. (NASDAQ:MTSC) in the S&P SmallCap 600 effective prior to the opening of trading on Thursday, April 8. S&P 500 constituent Amphenol Corp. (NYSE: APH) is acquiring MTS Systems in a deal expected to be completed soon pending final closing conditions.
