

# Two Harbors Investment Set to Join S&P SmallCap 600

NEW YORK, June 16, 2021 /PRNewswire/ -- Two Harbors Investment Corp. (NYSE:TWO) will replace Cardtronics plc (NASDAQ:CATM) in the S&P SmallCap 600 effective prior to the opening of trading on Tuesday, June 22. S&P MidCap 400 constituent NCR Corp. (NYSE: NCR) is acquiring Cardtronics in a deal expected to be completed soon pending final closing conditions.
